



SEVENOAKS DAY NURSERY

SDN Reserves Policy

We believe it is in the best interests of the Charity that reserves be held for the following purposes:-

1. To provide working capital for the day-to-day operation of the nursery
2. To provide for our statutory obligations in the unlikely event of closure
3. To provide funds for the future accommodation of the Nursery

1. Working Capital Reserve

Funds for this purpose should not exceed an average of one calendar month's cash outgoings. At the date of this policy, this amounted to £30,000.

2. Closure Reserve

Funds should be held in reserve to cover our statutory obligations in the event of closure. At the date of this policy the only known obligation is redundancy pay which would amount to no more than £50,000.

3. Accommodation Reserve

Our new buildings cost £450,000 (August 2019) and have an expected lifespan of 25 years. It is our intention that a reserve is accumulated over the next 25 years to provide for the future accommodation of the Nursery. At an average inflation rate of 2.5%, over the next 25 years we would need to save £840,000 to replace the new buildings.

This policy was adopted at a meeting of the Trustees of Sevenoaks Day Nursery CIO on 1st August 2019.
